

\$100 deposit required to hold your date. Deposits are applied to your final bill.

Day groups must pay a \$100 facility fee.

The cost for most day groups is \$10 per person which includes lunch about 6 hours at CVP. For a day at camp and dinner, the cost is \$12 per person.

All day groups must pay for a minimum of 50 guests.

Group's final number is required no less than one week prior to arrival.

Cancellations must be given no less than two weeks prior to arrival. CVP reserves the right to charge groups for their minimum guaranteed amount if group cancels later than two weeks prior to their event.

Group is required to use CVP lifeguards when using the waterfront. There is an additional cost of \$10 per hour for each lifeguard. A minimum of 3 lifeguards required to adequately monitor all of the waterfront activities.

Group will be sent an updated invoice after their event.

Group will be responsible for any damages to the facility/equipment by their attendees.

Group assumes full responsibility for its guests for any accident or personal injury or property damage that may occur at CVP.

Group releases and holds harmless CVP and its employees from all claims, liabilities, suits or damages.

Each individual from the group must sign our CVP Liability Release form.

For youth groups, at least one adult leader must occupy each cabin with campers.

Smoking is prohibited on the grounds and in any buildings.

Use of alcohol or any illegal drugs are prohibited on the Vesper Point grounds.

Please do not bring any food into the cabins. If you must have food in your cabin, make sure it is in a sealed container.

Guests are not allowed in the kitchen.

Vehicles should be parked in the designated parking lots only (not around the Dining Hall).

The front gate is closed and locked every night at 11:00 p.m. and is opened each morning at 7:00 a.m. This is to protect the camp property and you. Please give advance notice if you will be arriving or departing between these designated times.

If participant is under 18: I am responsible for this participant, and hereby grant permission for him/her to participate fully in said activities, and hereby give permission to said church, its trustees, officers, employees, agents, and any volunteers acting on its behalf to authorize and obtain emergency medical treatment for this participant. I assume the responsibility of all medical bills, if any.

Should it be necessary for the participant to return home due to medical reasons, disciplinary action, or otherwise, I assume all transportation costs.
